Monthly reporting and statistics on renminbi (RMB) progress towards becoming an international currency

September 2020

In August 2020, the RMB has retained its position as the fifth most active currency for global payments by value, with a share of 1.91%. Overall, RMB payments value decreased by 8.33% compared to July 2020, whilst in general all payments currencies decreased by 10.30%.


In terms of international payments excluding payments within the Eurozone, the RMB ranked 7th with a share of 1.21% in August 2020.




RMB's share as a global payments currency






RMB's share as an international payments currency - Excluding payments within Eurozone






Offshore RMB payments evolution






RMB's share as a global currency in trade finance market


