

## LICENSE TERMS FOR SAMPLE SOURCE CODE FOR DIRECTORIES DOWNLOAD AUTOMATION

## **April - 2009**

The present license terms (the License) govern the use of the sample source code made available for Directories Download Automation (the Sample Source Code) by SWIFT users and partners (the Customer).

The Sample Source Code is developed and made available by the Society for Worldwide Interbank Financial Telecommunication SCRL, a cooperative company with limited liability with registered office at avenue Adèle 1, 1310 La Hulpe, Belgium, and company registration number RPM Nivelles 0413.330.856 (SWIFT).

- 1. Product Description. The Sample Source Code is a human-readable computer programme code illustrating how a Customer can program a client application to automatically download the monthly BIC Directory, BICPlusIBAN Directory, Alliance Bank File, SEPA Routing Directory, EURO1/STEP1 Directory, and Country/Currency/Holiday files (the monthly BIC files). The Sample Source Code are available free of charge through a service that is only accessible through a HTTPS website communicated by SWIFT in the Directories Download Specifications documentation.
- 2. Copyright Ownership. SWIFT retains all copyright on the Sample Source Code.
- 3. Permitted Use. SWIFT grants the Customer a personal right to use and adapt the Sample Source Code for the sole purpose of automating the download of the monthly BIC files from www.swift.com. The Customer may not assign the License without prior permission of SWIFT. Any other uses of the Sample Source Code are expressly reserved to SWIFT, including the right to make the Sample Source Code available to third parties.
- 4. Releases. SWIFT may decide to release new versions of the Sample Source Code. The Customer must always use the latest version of the Sample Source Code and discard all previous versions, and agrees not to hold SWIFT liable for any damages caused by the use of outdated versions. For the avoidance of doubt, this provision may not be construed as implying any obligation for SWIFT to release new versions.
- 5. <u>Warranties</u>. Although SWIFT uses commercially reasonable efforts to ensure the quality of the Sample Source Code, it is provided without any express or implied warranties as to their completeness, fitness for a particular purpose, frequency of updates, ease of maintenance, or absence of errors.
- 6. <u>Liability</u>. Considering SWIFT offers the Sample Source Code free of charge and for the Customer's sole convenience, SWIFT excludes its liability for any direct, indirect, special or consequential damages caused by the use of the Sample Source Code.
- 7. <u>Licence Changes and Termination.</u> SWIFT reserves the right to modify any provision of the Licence and to suspend or discontinue the provision of the
