Minutes

- 1. Previous meeting notes from 12th October 2017 are approved.
- 2. CGI-MP membership updates : Mrs. Petra Kessner elaborates about ongoing discussions with SWIFT regarding CGI-MP support. Two main topics are addressed :
 - Use of SWIFT tool My Standards : ongoing pilots with WG1 and WG2. Availability of Excel documents, maintenance of current web site, access to My Standards and further use of tool functionalities are the topics to be clarified during the pilot phase. Question about other similar tools in the market was raised.
 - Onboarding of new members, maintenance of distribution lists : now responsibility of CGI-MP co-Conveners (ie Petra Kessner & François Lemaire)
 - Technical support for plenary meeting organization and some exceptional others : under examination by SWIFT (Mr. Andrew. Muir, SWIFT Standards)

<u>Special issue</u> : WG1 liaise with SWIFT Corporate pilot around GPI. SWIFT is currently running a pilot with several corporates, vendors and banks on initiating GPI-compatible payments, a.o. including UETR reference. It is proposed that CGI-MP waits for the results of the pilot before publishing specific guidelines. No objection was raised.
