

# RMB Tracker Monthly reporting and statistics on renminbi (RMB) progress towards becoming an international currency

In December 2022, the RMB has retained its position as the fifth most active currency for global payments by value, with a share of 2.15%. Overall, RMB payments value decreased by 6.79% compared to November 2022, whilst in general all payments currencies increased by 2.49%.

In terms of international payments excluding payments within the Eurozone, the RMB ranked 7th with a share of 1.47% in December 2022.









Customer initiated and institutional payments. Excluding China. Messages exchanged on SWIFT. Based on value.





## Evolution of RMB's share as a global payments currency






# RMB's share as a global currency in trade finance market


