#### 1. Previous meeting notes from 2015-06-23


- Harri Rantanen opened the meeting and welcomed participants (42)
- <u>Notes from previous Plenary, 23 June 2015</u> were accepted without change.

#### 2. CGI-MP update on governance

- David Dobbing reported on the membership status. As of 30 September 2015, there are now 143 registered CGI members, 48 FIs and 95 Non-FIs.
  Four new members have joined since the previous Plenary; UNIFITS, First Gulf Bank, ThyssenKrupp, EastNets. Application from Mentor Graphics Corporation received today.
- He updated the Plenary on the incident last week arising from an email loop that gave rise to a flood of spam emails on the CGI-MP Plenary email distribution list operated by SWIFT. Root cause was two dead email addresses and an incorrectly configured external mail server. This list has been closed and internal SWIFT deliberations are ongoing with respect to the future operation of this and the other CGI-MP lists. SWIFT will inform the CGI-MP Management Team on outcome and recommendations.
