1. Previous meeting notes from 2014-04-08

- Harri Rantanen opened the meeting and welcomed participants (30)
- Notes from previous Plenary, 08 April 2014 were accepted without change.


2. CGI update on governance

- Mr. Harri Rantanen and Mr. Stig Korsgaard were announced as continuing in their respective roles as the Financial Institution and Non-Financial Institution CGI-MP co-conveners for the second two year term (2014-07-01 2016-06-30). No other nominations were received before the nomination period end-date 2014-05-30.
- David Dobbing reported on the membership status. As of 24 June 2014, there are now 98 registered CGI members, 38 FIs and 60 Non-FIs.
 Five new members have joined since the previous Plenary; Nike, Wall Street Systems, Swedish Bankers Association, KPMG, and Erste Group Bank.
- CGI Web Site updated with new logo and rebranded as "CGI-MP".
- Harri Rantanen reported that current CGI has Web pages in Spanish and French. CGI-MP logo on these pages needs to be updated. David Dobbing undertook to have this addressed.



3. WG updates by Susan Colles, Kerstin Schoenwitz, François Lemaire and Glen Solimine

• Susan Colles reported on **WG1**, Credit Transfer and Status Report:

 Bi-weekly conference calls (normally Thu 3:00PM CET, 09:00AM EST, 1 Hr)

Over the course of April and June, WG1 completed updates to Appendix B for China domestic wires and for Ukraine domestic non-urgent and urgent payments. In addition a new Appendix B column was added for CNY cross-border payments. Other columns can similarly be added when the need arises. New versions of Appendix A (Payment System References) and B (Country Specific Requirements) were published.

Work by two WG1 subgroups (Thailand and Malaysia) being progressed, and recent Russia updates being reviewed with the local Market Practice Group. Market practice in India surrounding the use of Category Purpose and Purpose is another topic under consideration. WG1 discussing merits to establishing a sub-working group to specifically develop market practice related to the new remittance advice messages (RemittanceAdviceV01 - remt.001.001.01 and RemittanceLocationAdviceV01 - remt.002.001.01).

Susan Coles gave announcement of her retirement and informed the Plenary that following a call for nominations for a WGI Facilitator that Peter Hoogervorst from Standard Chartered Bank will be her replacement. Peter thanked Susan for her strong leadership of WG1 since its



inception in 2010. Harri Rantanen endorsed these comments and thanked Susan and welcomed Peter to the CGI-MP Management Team.

Common Global Implementation Market Practice (CGI MP) initiative

Antje Reichert recently stepped down as the WG2 Facilitator. Kerstin Schoenwitz acting as back-up gave the WG2 report. Harri Rantanen reported that the post of WG2 Facilitator is still open, both WG2 (and CGI-MP Plenary) members are welcome to advise their willingness to undertake the position. He thanked Antje Reichert for her excellent contribution to work of CGI-MP, in particular WG2.


Recent WG2 discussion has focused on market requirements for the reporting of return/reject reasons, notably for SEPA direct debits. Two different approaches have been suggested by the French and German Banking Associations. WG2 in discussion with WG3 is seeking to define a common approach.

Similarly, WG2 recommendations are required on Sequence Type reporting and on reporting of Compensation Amount.



In the absence of support, WG2 has decided to withdraw further consideration of a Change Request to restrict multiple transaction details per batch to a single occurrence.


Bi-weekly conference calls, new schedule to be advised by Facilitator.

WG3 established a sub-working group late last year focusing on Asian country requirements and has finalised entries for Hong Kong and Singapore. Other regional countries under consideration. An updated Appendix B is targeted for publication.

Ongoing WG3 topics include the handling of direct debit returns (rejections and refunds) and reporting of same. Documenting reporting requirements is a collaborative effort with WG2, taking into account the implementation approaches recommended for SEPA.



• Glen Solimine reported on WG4, eBAM (electronic Bank Account Management).



- 15 acmt (Account Management) messages

Weekly conference calls, scheduled and advised by Facilitator.

Corporate traffic volumes picking up (informal count, some 200 transactions per month), gaining a good understanding of broad usage, collecting feedback on what's working and what's not working.

Focus is to foster adoption of common standards for bank account management and to specify a base from which market practice can evolve, simplicity being a key criterion.

V1.H2 (Version 1, Harmonisation 2) template has been posted on the CGI-MP Web site as part of the public 45 day review cycle (ends August 8th 2014). At the end of this review period, WG4 will review and dispose of all the comments as received. WG4 will subsequently submit the final draft to CGI-MP Management Team, and in accordance with procedures, the Management Team will distribute the final draft to CGI-MP Membership for approval.

As part of this process, WG4 plans to conduct an information sharing session on its work over the coming weeks, an invitation to go out to CGI-MP Plenary membership.

WG4 is planning, in addition to the implementation templates, to prepare market practice documentation to assist in ensuring consistency of interpretation of the eBAM standards. Finally work will commence on reconciling V1 of the ISO 20022 Account Management messages with V2. In response to a version question, Glen Solimine explained that WG4 had started with V1 because it was the most widely used version and was the subject of existing



investment. This emphasis reflected on the CGI-MP version support statement on the <u>CG-MP</u> <u>Web site</u>.

4. Suggestions for new messages into the CGI-MP work

Harri Rantanen introduced two topics.

- 1) Bank Services Billing, ISO 20022 camt.086 message, the result of reverse-engineering an existing TWIST message standard into an ISO 20022 compliant message.
- There has been a request from German Association of Corporate Treasurers to add camt.086 message into the CGI-MP scope of work. This request was discussed in detail within the CGI-MP Management Team. The Team acknowledged that it may be difficult for corporate end-users to compare different banks' output messages due to lack of harmonisation across the bank content formats. On the bank side there is a dependency on their core systems' invoicing processes which in itself presents a challenge to achieve harmonization.

Therefore the CGI-MP Management Team does not recommend going forward with this initiative without clarity on the scope and sufficient resources willing to undertake the task. The Management Team proposed that a CGI-MP Task Force be created to undertake a feasibility study and to report back at the next Plenary on recommendations for decision. This proposal was endorsed by the Plenary with a call for Plenary to nominate members to the Task Force by the 2014-07-03, end-of-business day. A minimum of at least five members was foreseen, including representatives from banks, vendors and end-user corporations. Standard Chartered (noting that the ISO 20022 format has to-date limited use) Efis, BNP Paribas, Deutsche Bank, and Citi Bank indicated their support for this initiative.

- 2) Remittance Advice, ISO 20022 remt.001 and remt.002 messages
- Both WG1 and WG3 have discussed if there is need to add the new remt.001 (RemittanceAdviceV01) and remt.002 (RemittanceLocationAdviceV01) messages into the respective group's agenda and scope for harmonization. The CGI-MP Management team proposed that both WG1 and WG3 groups jointly continue with their evaluation and determine whether there is a need to set up separate guidance for the remt.001 and remt.002 messages from a payment and direct debit initiation perspective. A decision on extending the WG1 and/or WG2 scope to cover these messages will be taken at the next Plenary.
