Related CGI-MP deliverables:

This is a list of CGI-MP normative deliverables which is impacted by the change request.

This Change Request proposes a new BTC table; it integrates additional BTC codes as well as new descriptions to apply to acmt.007, acmt.014, and acmt.017 message fields.

Since the previous table did not correspond with Banks and Corporates expectations, a new table with proprietary codes was consequently developed and will after be presented to ISO 20022 to become eBAM standard codes.

B. Description of the change request:

The change request form must be exhaustive for all particular change requested to each normative CGI-MP deliverable (for example, adding, deleting, modifying, renaming, changing the cardinality, moving an element/component, or changing the type of an element, changing a code list. adding new functionality which requires several changes).

Change requests may not lead to creation of new messages. In such cases, a new work item proposal needs to be submitted to the CGI-MP Plenary.

- 1. Appropriate codes from the ISO BTC Table have been selected for Account Management and Payment domains
- 2. Improved BTC descriptions are used to better specify the context of Account and Mandate Management. Verbs such as to sign, to open, to request, to order have been used

Examples:

- > PMNT/ICDT/XBCT
 - ISO BTC Definition: Transaction is cross-border credit transfer
 - > New definition: Sign all cross-border credit transfers.
- > PMNT/CNTR/CHKD
 - ISO BTC Definition: Transaction is a counter or safe cash deposit operation, related to coin and currency deposit
 - > New definition: Deposit Cheques
- 3. New proprietary codes have been introduced to better manage Mandate Management at macro and micro levels

The proposed nomenclatures for proprietary codes are similar to ISO domain/family/sub-family.

Domain (4 chars): D + 3 chars with a numbering between 001 to 999
 Thus: D001, D002, ..., D999

- Family (4 chars): F + 3 chars with a numbering between 001 to 999
 Thus: F001, F002, ..., F999
- *Sub-Family (4 chars): S* + *3 chars with a numbering between 001 to 999*

➤ Thus: S001, S002, ..., S999

Thus, the codes should look as follow ACMT/F002/S017 = Block bank card.

4. A Generic code "All Powers" with the meaning "All" has been introduced

The selection of an "all" in a Domain or Family or Sub-Family = the sum of all BTC of the level within the limits of mandates managed by the bank for the country and the Applicable Channel.

Examples:

- > ACMT/F000/S000 = Sign all bank account management requests
- D000/F000/S000 = Hold all bank mandates, without any restriction or reserve, on behalf of the company, except the mandate of subdelegation


